Agreement of Living Souls/Vessels


Dear Justice Naidu,

We also wish to strive to build our Community/Nation for the betterment of future generations yet borne. To achieve our vision, we would like your acceptance of our appointment of you as Chief Justice Mentor to help nexus others/courts with us in our courts and if need be consult with us on issues that bind us all as live borne humans/nations on mother earth.

There are many issues, cases and controversies that need to be addressed, and, Your Honor's name was highly recommended to help, (by, Sui Juris Court Angels Foundation) and handle these matters as we bring to you, to find process/communicate to bring solutions/remedy. We can no longer tolerate foreign systems that put encroachments on our valuable lands/resources as Tribal Nations of Alaska. We need your presence in our Nations to redeem all that was lost to greed/adventure with reckless abandon, brought on by those who came onto our shores/lands/soils and took without our consent or agreement.

We look forward to your accepting this offer based on a Treaty of Peace, Partnership and Prosperity we the Council of the Akiachak Native Community wish to establish and conclude with Royal Borneo Nations; as Alaska's First Nations and Peoples.


